We have received your vote by mail ballot and it is missing a signature. In order to ensure that your vote by mail ballot will be counted, the Unsigned Ballot Statement must be completed and returned as soon as possible.

The Unsigned Ballot Statement must be received by the election's official of the county where you are registered to vote **no later than 5 p.m. September 24, 2021.**

The signature provided may be added to the Voter's registration record to be used for signature comparison purposes in future election, if the signature provided in the cure compares to the signature(s) of the voter in the voter's record.

If you do not wish to send the Unsigned Ballot Statement by mail or have it delivered, you may submit your completed Unsigned Ballot Statement by email or facsimile transmission.

In order for your ballot to count:

- **SIGN this letter and deliver it or have it delivered to our office in person** at 633 Washington Street, Room 17, Red Bluff, CA 96080, Monday through Friday 8:00 am to 12:00 pm or 1:00 pm to 5:00 pm **by 5:00 pm on September 24, 2021**; OR
- **SIGN this letter and deliver it any polling location on Election Day or the Ballot Drop Box** located on the corner of Madison and Pine Streets, near the old County Library prior to **8:00 pm on Election Day, September 14, 2021**; OR
- **SIGN this letter and return it to our office via mail.** After signing, mail your statement in the enclosed envelope with sufficient postage to our office. It must be received at our office at PO Box 250, Red Bluff, CA 96080 before **5:00 pm on September 24, 2021.** Postmarks will not count; OR
- **Fax or Scan and email this letter to our office.** It must be received at our office before **5:00 pm on September 24, 2021.** Fax (530) 527-1140, email: [elections@co.tehama.ca.us](mailto:elections@co.tehama.ca.us)

I understand that my failure to sign this statement means that my vote by mail ballot will be invalidated.
