AMENDMENT TO THE EMPLOYMENT AGREEMENT BETWEEN THE COUNTY OF TEHAMA AND CORAL FERRIN FOR THE POSITION OF PERSONNEL DIRECTOR

The Employment Agreement made and entered into on the 20th day of November, 2020 by and between the County of Tehama (COUNTY), and CORAL FERRIN (FERRIN), identified as Misc. Agreement No. 2020-308, shall be amended as set forth herein.

I. Section 3: Salary shall be amended to read as follows:

For purposes of this agreement, FERRIN shall be considered an overtime-exempt County employee. The salary and benefits provided under this agreement shall constitute the total compensation for all services provided by FERRIN under this agreement.

In full consideration for services rendered, and the satisfactory job performance of specified duties, the COUNTY agrees to pay FERRIN hereto an annual salary, payable in twenty-six (26) installments, on the same biweekly basis as other employees of the COUNTY, and prorated on actual hours worked within the annual period. Annual salaries will be as follows:

November 1, 2020 through October 31, 2021 November 1, 2021 through November 8, 2021	\$88,452.00 Annually
November 9, 2021 through October 31, 2022	\$92,880.00 Annually \$97,524.00 Annually
November 1, 2022 through October 31, 2023	\$102,401.00 Annually

Notwithstanding any other provisions of this contract, COUNTY'S Board of Supervisors reserves the right, in its sole discretion, to increase the compensation paid by COUNTY to FERRIN during the term of this contract. The compensation stated in this contract shall not be deemed to be a fixed amount for the entire term of this contract, and may be increased, in the discretion of the Board of Supervisors, consistent with the California Constitution, Article XI, Section 10, subdivision (a).

COUNTY shall not at any time during the term of this agreement reduce the salary, compensation or other financial benefits of FERRIN, except with the concurrence of FERRIN and then only to the degree of such a reduction across-the-board for all employees of the Department in which FERRIN is employed (including a reduction resulting from employee furloughs).

Except as provided in the cell phone allowance, partial months will be prorated based on the number of days this contract is in force during the month calculated as a percentage of the total number of calendar days in the month.
