Drop Box Overview

Tehama County Elections has five drop box locations for the June 7, 2022 Statewide Primary Election. By law drop boxes must be open for voters beginning 29 days before the election. They will remain open until the polls close on election day at 8pm.

One of the drop box locations in the county are outside and accessible to the public 24 hours a day and 7 days a week.

The drop box location is as follows:

Corner of Pine and Madison Street – Red Bluff, CA 96080

The other five boxes are located inside various businesses throughout the County. These boxes will only be available to the public during normal store hours.

Tehama County Elections staff will visit these businesses on the morning of May 9th and set up the drop boxes at previously decided locations. This guide has photos of the drop box locations at each location.

Tehama County Elections staff will be responsible for setting up and packing up the boxes, retrieving the ballots from them, and performing maintenance checks. Please reach out to our office if the box is tampered with, overflowing with ballots or if someone has tried to take the box or ballots. Thank you.

The drop box locations are as follows:

Historic Courthouse Lobby – 633 Washington Street, Red Bluff, CA 96080

Food Maxx – 94 Belle Mill Rd., Red Bluff, CA 96080

Nu-Way Market – 8049 Hwy 99E, Los Molinos, CA 96055

Corning City Hall, - 794 3rd Street, Coning, CA 96021

Raley's – 725 S Main Street, Red Bluff, CA 96080

Chain of Custody Procedures for Drop off Boxes

The ballot retrieval logs will be printed on 2-part NCR paper

- Two designated ballot retrievers or Election employees will retrieve from the Drop off Boxes. Each retriever shall wear a badge that identifies them as a ballot retriever. They will take the County Oath prior to retrieving ballots for the Election cycle
- Only designated ballot retrievers or Election employees may transport the retrieved ballots
- The designated retrievers will note on the Ballot Retrieval Log the Drop Off Box number, location, date and time of arrival
- They shall confirm the seal numbers on the outside of the drop box match the security seal log located inside the drop box and write the new seal numbers on the security seal log before placing the log back inside the drop box
- The designated ballot retrievers shall retrieve the ballots from the secure ballot container that is placed inside the drop box and shall place an empty secure ballot container inside the drop box prior to departure.
- The designated ballot retrievers will apply a green tail seal to the secure ballot container for transport back to the office and log the seal number on the Ballot Retrieval Log
- The designated ballot retrievers will note the time of departure the Ballot Retrieval Log
- Both ballot retrievers will sign the Ballot Retrieval Log and note the arrival time in the office.
- A separate Election employee will confirm date and time of receipt, inspect for tampering and sign the log
- An election employee will write down the number of ballots received at the Drop Box.
- One part of the Ballot Retrieval Log will be placed with the unscanned ballots until time of scanning and processing
- The other part of the Ballot Retrieval Log will be stored with other logs in the vault until certification and then stored with the election for the prescribed amount of time
- The drop boxes will be removed from their locations or locked at 8pm Election night after the polls close (*unless there are voters in line at 8 pm or a court order has been issued extending the time for the closing of the polls.*)

Put this log sheet into the side pocket of the secure transport bag and transport to Elections Office.
