TEHAMA COUNTY

Nestled in the northern Sacramento Valley, Tehama County lies approximately midway between Sacramento and the Oregon border. The County sits alongside the beautiful Sacramento River and is only 50 miles west of Lassen National Park. Tehama County is the central point of widespread recreation; with nearby camping, hunting, fishing, golfing, snow skiing, and boating resources as good as or better than anywhere in California. Tehama County is home to approximately 65,000 people. In our County's small town atmosphere, you can experience the feeling of knowing your neighbors. Additionally, the mean travel time to work is only 23 minutes and the cost of living in Tehama County is lower than many other places in California.

The strong western heritage will capture your heart and awaken your spirit. Some of the best western events in California occur in Red Bluff, including the Red Bluff Round-Up Rodeo, and the Annual Bull and Gelding Sale, the largest in the nation. The old Victorian west lives on here. Main Street is dotted with quaint shops offering antiques and collectibles. The Sacramento River provides an endless variety of outdoor recreation and is one of the largest salmon spawning rivers in the world. Red Bluff is also considered the gateway to the renowned Lassen Volcanic National Park, encompassing 166 square miles of spectacular volcanic exhibits and the formidable Lassen Peak. The town of Corning is the center of Northern California's award- winning olive oil producers and olive product retailers.

The Position

The Substance Use Recovery Director develops, administers, and supervises the Substance Use Recovery Center of the Health Services Agency. Coordinates public relations efforts; develops funding resources and manages the center budget. Performs related administrative and professional work as required. Under direction, performs the duties of Alcohol and Drug Program Administrator as outlined in the California Health & Safety Code §11801. As a center director, this position exercises independent judgment for directing the treatment provided to clients, according to ethical and legal standards.

The ideal candidate will be a mission driven leader with an innovative mindset, committed to removing barriers to services for disenfranchised communities and those with the poorest outcomes related to health. The Substance Use Recovery Director reports to the Health Services Agency Assistant Executive Director of Program.
